### Sewerage Tariff Structure for the period 2024/2025 to 2028/2029

- Consumers with a Water Connection**  
 Sewerage will be charged at 75% of the water volumes, billed at the tariff for water specified (in 2.0) above for all customer categories.
- Consumers without a Water Connection**  
 Sewerage consumers without a water connection shall be charged as follows:
  - Single dwelling Domestic unit: Ksh. 350 Per Month
  - All other categories: 75% of the Volume of water consumed as per the metered source at the rates specified (in 2.0) above.

### Miscellaneous Charges

Miscellaneous charges and Conditions attached to the tariff remain as per the approved miscellaneous charges approved by the Water Services Regulatory Board (WASREB) and as shared on the NAIVAWASCO's Website.
